The company mentions bribery and corruption as behaviours that will not be tolerated but this is indirect and not supported by a senior leadership figure.

There is evidence that the company has an anti-corruption policy, which prohibits bribery and applies to all employees and board members.

However, the policy does not explicitly prohibit payments to public officials or facilitation payments. It is also unclear whether the policy applies to the staff and leadership of subsidiaries and other controlled entities. While the company states that more detail on its ethical commitments can be found in the GKN Aerospace Code and Policies, this document is not publicly accessible.

The Company operates and encourages the use of a confidential and anonymous whistleblowing hotline. The hotline is operated by an independent external service provider, which allows employees to speak in confidence to someone who is neither another employee nor their line manager. The external provider reports all employee disclosures to the Company's central legal function, who investigate calls to the hotline independently from the Company's management. The hotline is a freephone telephone number, which is widely publicised at the Company's site, on the Code and via the Company's intranet.

Comments

There is some evidence that the company ensures that its suppliers have adequate anti-bribery and corruption policies and procedures in place, which prohibit bribery and facilitation payments, and that have procedures related to conflicts of interest and gifts and hospitality. The company also states that it has the right to audit suppliers and that it assures itself on an annual basis of its suppliers' adherence to its principles.

However, it is unclear if it conducts this assurance for all suppliers, or whether the company assures itself of this whenever there is a significant change in the business relationship. Additionally, there is no evidence that the company's suppliers are required to have a procedure for whistleblowing.

- Neither pay nor accept (nor tolerate anyone else paying or accepting) any bribes, 'kickbacks' or other similar payments or inducements. This includes 'facilitation payments' made to facilitate or speed up official or governmental procedures.


